4. Declaration of interests on agenda items. None

5. Minutes. The minutes of the 19th April General Meeting 2018 were proposed Mr Todd seconded Mrs Edge and carried.

6. Matters arising

6.1 Pot Holes East Lane /Stanhoe Road have been reported to Highways.

6.2 Wall Manor House. The clerk read a letter from the resident informing the council a builder has been engaged to inspect and carry out remedial work on the wall.

6.3 Pond Bradmere Lane. The clerk had received an email from Councillor Morrison that suggested the Parish contact Norfolk Wildlife Trust. The clerk will write to them.

6.4 Visit by Henry Bellingham. The clerk has emailed but not received a date.

6.5 Electricity from the Recycling Centre. The clerk had received an email which he read to the meeting. It explained the processes going on at the site and the fact that there is no surplus electricity to either use in the village or money that could be distributed to villagers.

6.6 Station Road defect. The clerk had received a reply from highways informing him that it was a BT trench and they will be asked to improve.

6.7 Gully Church Place. The clerk had received an email from Highways to inform him this had been cleaned.

7. Correspondence.

7.1 Pond Station Road. Email from Highways to inform the council they would not be doing any work on the pond as it is not theirs. The pond has no ownership. An estimate for clearing could be in the region of £5000

7.2 Sara Young re street naming new development on the Brancaster Road. After discussion it was agreed North something could be a good option. Seal Court/Close was suggested as it was the seal sanctuary in the past. The clerk will email the decisions.

The Bowls Club asked for support with a large bill for their mower and The Ripper Hall Committee asked for a donation to the roof fund. It was proposed by Mr Todd and seconded Mr Cooke £500 be given to the Bowls Club this was carried. Mr Crompton proposed and Mr Wroth seconded £500 be given to the Ripper Hall, this was carried. This now concludes charity donations for the current year.
